For the first time during dialogue between the IGA (Initiative for Health and Work) experts, a topical scientific issue - the changing of health behaviour - was debated in a small group by scientists and practitioners. The health theory of Professor Ralf Schwarzer addresses the essential components that need to be influenced for people to change their behaviour. This applies both to health behaviour as well as safety consciousness at the workplace. more...
