work. in tune with life. move europe - Official Opening of the new ENWHP Campaign by the European Commission

On the 8th and 9th October 2009, the new ENWHP campaign will be opened officially by the European Commission at the joint ProMenPol/ENWHP Conference in Berlin. THIRD CONFERENCE OF THE BULGARIAN FORUM "HEALTHY AND SAFE WORKPLACES" / SECOND ENWHP ROUNDTABLE MEETING ON WORKPLACE HEALTH PROMOTION IN BULGARIA

The Third conference of the Bulgarian Forum "Healthy and Safe Workplaces" (BF"HSW") under the motto "Healthy work - healthy lifestyle - healthy business" was held on July 9,2009. The traditional place of the Conference was the auditorium of the National Centre of Public Health Protection (NCPHP) in Sofia. It was organised in partnership by the Secretariat of the European Network for Workplace Health Promotion (ENWHP) and NCPHP.

Stress - Mind - Health. The START procedure for the risk assessment and risk management of work-related stress

The assessment of (inappropriate) mental stress in the workplace according to the requirements of the Labour Protection Law meets with problems in many companies. This concerns in particular the choice of suitable methods and the expenditure required to put them into practice in terms of staff, finances and time. On the other hand, up to now only a comparatively small number of company managers have seen the opportunities offered in implementing an overall risk assessment as an effective structuring of work. more...

Is it worth investing in mental health promotion and the prevention of mental illness?

While evidence on the cost of mental illness is growing, little is known about the cost-effectiveness of programmes in the field of mental health promotion (MHP) and mental disorder prevention (MDP). This paper aims at identifying and assessing economic evaluations in both these areas to support evidence based prioritisation of resource allocation. more...
